INSTRUCTIONS TO THE CANDIDATES

1. Each application for REVALUATION should be sent to **The DEAN, UG Examinations, Sri Krishnadevaraya University, Ananthapuramu - 515 003 (A.P.)**
2. Each application for PERSONAL IDENTIFICATION should be submitted in person before 1 p.m. at the O/o. **The DEAN UG Examinations, Sri Krishnadevaraya University, Ananthapuramu - 515 003, (A.P.)** and Answer Script will be shown to the candidate from 2.30 p.m. to 4.30 p.m on words on all working days.
3. Last date for receipt of applications is fixed 21 (Twenty One) days from the date of publication of results by the University. *(For example, if the date of publication of results is 11-06-2016, the last date for receipt of applications for Revaluation / Personal Identification is 30-06-2016).*
Note : The date of receipt of marks memorandum by the candidate will not be taken into consideration.
4. REVALUATION means the Answer Script of the candidate is valued again, and he/she will be informed by the University about the revision of marks as obtained in the revaluation. If no information is received by the candidate after 45 days from the last date prescribed for applying revaluation, the candidates are requested to contact the University Office for knowing results. This year, the UG Exams intended to kept the revaluation results in the SKU website only, all the candidates are advised to visit University website www.skugexams.org to know their results. **No individual intimation letter will be sent to the candidates. A press note will be issued about the date of release of revaluation results.**
5. **No provision of revaluation in respect of Practical examination.**
6. Applications received with insufficient particulars and fee will be summarily rejected.
7. **The result of the revaluation can be expected before the commencement of the next examination or later. Hence, the failed candidates who applied for revaluation are advised to pay the examination fee and appear for the examinations without waiting for revaluation of results.**
8. Applications (along with D.D) received after the due date, will be summarily rejected. Hence the candidates are advised to apply well in advance and this office is not responsible for any postal delays.
9. Fee once paid shall not be refunded under any circumstances.
10. The Fee :- By **Demand Draft** drawn in favour of the **Registrar** Sri Krishnadevaraya University, payable at **SBI, S.K.University Branch** The candidates are advised to obtain Demand Drafts either in **State Bank of India** only. Other Bank Demand Drafts are not acceptable and such application will be returned to the candidate.
